VOLUNTARY ANNOUNCEMENT

COLLABORATION FRAMEWORK AGREEMENT WITH DUSHU LAKE HOSPITAL

This announcement is made by Suzhou Basecare Medical Corporation Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis to inform the shareholders and potential investors of the Company about the latest business advancement of the Group.

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that the Company entered into a collaboration framework agreement (the “**Collaboration Framework Agreement**”) with Dushu Lake Hospital Affiliated to Soochow University (蘇州大學附屬獨墅湖醫院) (“**Dushu Lake Hospital**”) on June 26, 2021. According to the Collaboration Framework Agreement:

1. both parties agreed to share a biomedical product R&D platform, and build cooperation in relation to basic experimental facilities and data information networks;
2. both parties agreed to share human and intellectual resources related to biomedical R&D;
3. both parties agreed to establish long-term cooperation in clinical trials of R&D of new medical devices, and we agreed to consider to choose Dushu Lake Hospital as our clinical center in new drug multi-center clinical trials;
4. both parties agreed to explore a new model for the transformation of biomedical achievements and to promote the clinical application of new devices and new therapies; and
5. both parties agreed to actively promote and organize academic activities.

Dushu Lake Hospital is the first public Class III hospital in Suzhou Industrial Park affiliated to Soochow University (蘇州大學). To the best knowledge of the Directors, Dushu Lake Hospital and Soochow University are independent third parties to our Company.
